SAILING INSTRUCTIONS

for

Handicap 1 to 4 Yachts and Restricted Sail Class

1. RULES

- 1.1 The regatta will be governed by the 'Rules' as defined in the current Racing Rules of Sailing 2017-2020 (RRS), and the Prescriptions of the RYA and their relevant Appendices.
- 1.2 The Conditions of Entry, the Rules of each Class, the Sailing Instructions, and any special instructions or amendments issued by the Organising Authority will apply. In the event of conflict these Sailing Instructions shall prevail.

2. NOTICES TO COMPETITORS

Notices to competitors will be posted on the official notice board located at Cove Sailing Club, which, for the purpose of these Sailing Instructions, is the Race Office.

3. CHANGES TO SAILING INSTRUCTIONS

Any change to these Sailing Instructions will be posted before 09:00 on the day it will take effect including the schedule of races.

4. SIGNALS MADE ASHORE

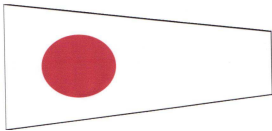
Signals made ashore will be displayed on the flagstaff outside the Race Office.

5. SCHEDULE OF RACES, STARTS, STARTING FLAGS & TIMES

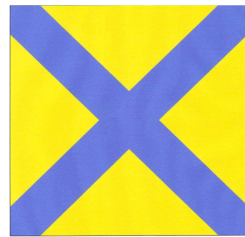
5.1 Racing is scheduled for yachts of the following Classes:

5.2 Handicap Classes will be split as follows:

IRC 1: IRC of 1.010 and above

IRC 2: IRC between 0.900 and 1.009

CYCA Handicap 3: 11.00 to 17.00 minutes/hour

CYCA Handicap 4: 17.25 minutes/hour and above

5.3 The separation of race results into Classes for the purpose of the issue of prizes will be at the discretion of the Organising Authority.

5.4 There will be a Time Signal at 12:50.

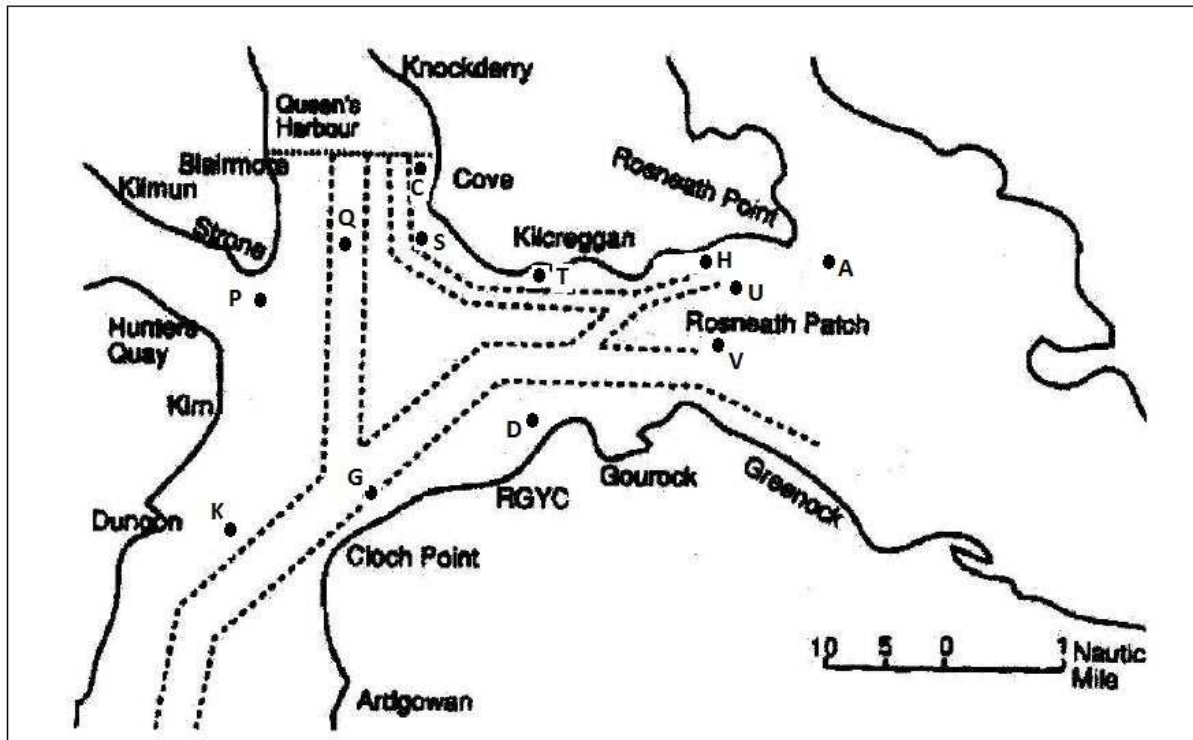

- 8.1. The course to be sailed will be indicated by displaying a white course letter on a black background in front of Cove Sailing Club.
- 8.2. The starting and finishing line shall be a straight line between the Cove Sailing Club main flagpole and Mark Z.

10. THE START

- 10.1 Races will be started using RRS 26.
- 10.2 The Starting Line will be between the Cove Clubhouse flagpole and Mark Z.

11. LONE YACHT AT THE START

In the event of only one yacht in either Start appearing at a Start Line no race will take place for that Start and no points will be awarded. The Start Sequence for subsequent starts will NOT be altered as a result of such occurrence.

12. KEEPING CLEAR

In addition to RRS 24.1 yachts shall keep clear of the Starting Line prior to their Warning Signal and of the Finishing Line after finishing.

13. TIME LIMITS

- 13.1 In addition to RRS 35, there will be a 'Fixed Time Limit' of 17.00 hours.
- 13.2 If by the 'Fixed Time Limit' no yacht in a Class has finished the race, but one or more yachts in that class have completed the first round, the race shall be deemed to have finished at the end of the completed round without regard to any subsequent event. Until the expiry of the 'Fixed Time Limit' all yachts are racing.
- 13.3 If no yacht has completed one round then the race will be considered abandoned.

14. PROTESTS AND REQUESTS FOR REDRESS

- 14.1 Protest forms are available from the Race Office. Protests shall be delivered there within the protest time limit.
- 14.2 For each Class, the protest time limit is 90 minutes after the last yacht has finished the last race of the day. The same protest time limit applies to all protests by the Race Committee and Protest Committee and to requests for redress. This changes RRS 61.3 and 62.2.
- 14.3 Parties to protests are advised to remain in the vicinity of the Race Office.

15. RESULTS

Results will be posted at the Race Office as soon as possible after racing and on the Club website as soon as practicable.

16. SCORING

- 16.1 The Low Point scoring system of RRS Appendix A will apply.

16.2 A yacht shall not count the result of a race unless the entry fee has been paid prior to the start of the Regatta.

17. SAFETY REGULATIONS

17.1 In addition to RRS 1.2 all yachts shall carry an anchor and warp, a tow line, and a bailing device each of which shall be of a type and size suitable for the purpose for which they are intended.

17.2 A yacht that retires from a race shall endeavour to notify the Race Office as soon as possible before leaving the Racing Area.

18. CLYDEPORT OPERATIONS LIMITED (COL) INSTRUCTIONS

18.1 **NARROW CHANNELS.** Attention is drawn to the International Regulations for the Prevention of Collision at Sea, 1972. Particular notice shall be taken of Rule 9b which states ‘a vessel of less than 20 metres in length or a sailing vessel shall not impede the passage of a vessel which can safely navigate only within a ‘Narrow Channel or Fairway’.

18.2 Whilst racing or on passage in the Firth of Clyde north of Cumbrae Head, yachts shall regard ‘Recommended Channels’, marked as dotted lines on Hydrographic Office charts as a ‘Narrow Channel’ within the meaning of IRPCS 9b. Furthermore Clydeport Operations Limited has decreed that any waters of the Firth of Clyde where vessels by virtue of size, draught, speed or proximity to land, hazards and other vessels are unable to manoeuvre freely must be regarded as a ‘Narrow Channel.’

18.3 Whilst racing, any yacht which is unable for reasons of lack of wind or other cause, to sail clear of a large power driven vessel shall start her engine and/or paddle in order to clear and thereafter shall report full details to the Race Committee.

18.4 Competitors are reminded of the Clydeport Operations Limited Byelaw which prohibits yachts and other craft from manoeuvring within 100 metres of any ferry terminal. Particular regard shall be paid to this when in the vicinity of the Caledonian MacBrayne and Western Ferries facilities at Gourock, Dunoon, McInroy’s Point, Hunter’s Quay, Largs, Cumbrae, Wemyss Bay and Rothesay.

19. RADIO COMMUNICATION

The Race Committee may maintain a watch on Channel 37, primarily for safety purposes.

20. PRIZES

Prizes will be awarded and trophies will be held until the following year’s Regatta.

21. INSURANCE

Each participating yacht shall be insured with valid third-party liability insurance with a minimum cover of £2 million.

22. DISCLAIMER OF LIABILITY

22.1 Competitors participate in the Regatta entirely at their own risk. See RRS 4, Decision to Race. The safety of a yacht and her entire management including civil responsibility to third parties shall be the sole responsibility of the owner/skipper racing the yacht. The establishment of these sailing instructions in no way limits or reduces the complete responsibility of the owner/skipper for his/her crew/yacht or equipment and the management thereof.

22.2 The Organising Club and their representatives disclaim any and every responsibility for any loss, damage, injury or inconvenience to persons, yachts or associated subjects howsoever arising directly or indirectly, ashore or afloat, from their policy, rules or ruling before, during and after the races and related activities.
